#### Letter from the Chair



Dear Supporters of the Wadebridge Festival of Music and Speech,

I have pleasure in sending you the Syllabus for our 2025 Centenary Festival. This year we are delighted to welcome Jenny Thornton AGSM(Teaching), ALAM(Acting, Public Speaking), CertEd, CDE, LISTD(Dance) as our Adjudicator for the Speech Classes.

Jenny is making a welcome return to the Festival. She was very popular with both performers and audiences during her last visit, and her encouragement and praise especially for younger performers was very well received, helping to build confidence for their futures.

We are also delighted to welcome back Bryan Husband GRSM, AWCMD and FISM to adjudicate our Music classes. Bryan is no stranger to our Festival and has been extremely popular in the past with his enormous experience and wonderful sense of humour.

There have been a few changes to our 2024 Syllabus, including a Music Theatre Group Class (34), a Jazz Ensemble Class (126) and four non competitive classes (16-19).

Entry fees remain as last year.

Our 2024 Gala Concert was a big success and we plan to hold two Concerts in our Centenary Year! The first will take place on Saturday 1<sup>st</sup> March immediately prior to the start of the Festival and there will be a Festival Celebration Concert on Saturday 8<sup>th</sup> March following the end of the Festival, both Concerts to be held in the Wadebridge Town Hall.

In line with other Festivals, we have decided to amend slightly the criteria for the award of trophies and cups in 2025 and beyond; we intend to present these where marks of 85 and over have been awarded by the Adjudicator.

Please note that we do not have an Official Accompanist. If you should require an

Accompanist, please see page 6 of the Syllabus for details of Ms Norton or Mrs Edney who may be able to assist you.

Our "Friends of the Festival" scheme has proved popular, whereby for a minimum donation of £20 for a single person or a couple you can gain access to all Festival sessions. This offers a substantial saving if you attend a number of sessions during the Festival week. #### **New Marking Scheme**

The British and Internation Federation of Festivals has recently introduced a new grading and marking system, full details of which are set out on page 5. We have adopted this system with effect from our 2025 Festival so please take a moment to familiarise yourself with this.

#### **Non Competitive Classes**

As a result of feedback, we have introduced four non competitive classes in the spoken word section. Classes 16,17,18 and 19 are now open to those performers who would like to receive comments on their performance but do not wish to be marked.

#### **Centenary Festival**

Given the importance of this achievement, we are planning an additional Centenary Concert as mentioned above and also a display of historic memorabilia relating to the Festival.

#### **Data protection**

Our Syllabus includes our Privacy Notice and the more detailed Privacy Policy can be found on the Festival website or obtained from the Secretary. Our entry forms require you to confirm that you are willing to give the necessary consents for this and our safeguarding policy. Parents or guardians need to do this for young people eighteen or under. Alternately, teachers can confirm that they have received the necessary consents for individual entries. We are very grateful for your co-operation. Please note that if you do not wish the name of a performer to appear in our programmes or the name of a winner to appear on our website or in the local press, you need to let us know at the time of entry.

The deadline for entries is Friday, 31st January 2025. Please do your best to get your entries to us on time. It is a complex task to prepare the programmes and this can only be done when we know the nature and number of entries. Details about how to enter, including how to pay our fees can be found on page 4 below.

Finally, I'd like to thank all those members of our Committee and our volunteers who help to make our annual event such a success. Also to the Wadebridge Town Council and the staff of the Wadebridge Town Hall for their considerable support. This event provides a marvellous opportunity for local talent to excel and receive expert adjudication and public recognition.

I very much look forward to welcoming you to our Centenary Festival in March.

# Gala Festival Concert

As this is our centenary year, there will be two Gala Festival Concerts held in Wadebridge Town Hall. One will be on Saturday 1<sup>st</sup> March and the other will be on Saturday 8<sup>th</sup> March. The theme of these concerts will be 'A Celebration of Local Music'.

# **Overall Trophies**

**The Wadebridge Choral Society Shield** will be awarded to the instrumentalist considered by the Adjudicator to be the Wadebridge Festival Instrumentalist of the year.

**The Daisy Rowe Memorial Trophy will be** awarded to the vocalist considered by the Adjudicator to be the Wadebridge Festival Singer of the Year.

**The Chrissie Clements Rose Bowl** will be awarded to the female with the highest mark in the Vocal Classes.

**The Clifton Gilbert Cup** will be awarded to the male with the highest mark in the Vocal Classes.

**The June Holmes Memorial Trophy** will be awarded to the competitor with the highest mark in the Speech Classes

**The Joyce Buse Memorial Trophy** will be awarded to the competitor with the highest mark in the Piano Classes.

**The Jack Wills Trophy** will be awarded to the competitor with the highest mark in the Brass section.

Trophies will be awarded to winners with a mark of 85 or more in classes where trophies are shown.

# Regulations: Please Read Carefully.

#### **Eligibility**

- 1. Where an age limit is given, it will be as of 3<sup>rd</sup> March 2025.
- 2. Competitors in all classes must be amateur (an amateur is considered to be one who does not derive the main part of his/her income from that section of the art in which he/she is proposing to enter the Festival). A professional may conduct in all classes as necessary.
- 3. No test pieces chosen for the 2024 Festival may be offered. The Adjudicator's decision shall be final in all matters relating to the performance and content of the entry. Competitors are asked to check carefully the eligibility of their *Own Choice* and to acknowledge that the quality of choice will be considered by the Adjudicator.
- 4. Competitors in Duet/Trio/Quartet Classes must perform separate parts.
- 5. Competitors can be accepted in more than one class in solo, duet, trio, quartet, or ensemble classes only if they offer a different composition for each entry.
- 6. Songs from musical theatre or barbershop can only be performed in the designated classes.
- 7. Competitors who enter classes where grades are indicated may perform in only one class per instrument and the pieces chosen must be appropriate to that grade. Competitors may not enter a class lower than the grade they have achieved. This applies to both players in Duet Classes.
- 8. Entries in the composition classes, including any poem or story, must be the competitor's own original work and be performed at the Festival. A copy for the Adjudicator, with the entry fee must be sent to the Entry Secretary by Friday, 31st January, 2025.

#### **Own Choice**

- 9. Own Choice items must not exceed 5 minutes' duration unless otherwise stated in class reference. Performances exceeding the time limit (where stipulated) will be adjudicated but not marked.
- 10. The title and author/composer of *Own Choice* pieces must be clearly announced by all competitors.
- 11. Own Choice songs should be appropriate to the age of the competitor.
- 12. A copy of *Own Choice* items, clearly marked with the competitor's name and the number of the class entered, must be provided for the Adjudicator and placed in the box provided in the entrance foyer at least 30 minutes before the start of the class.

#### **Accompanists**

13. If required, competitors must provide their own accompanist. Accompanist's fees are not included in the Entry Fee. See page 6.

14. If using a backing track competitors are responsible for providing their own equipment. The part of the solo instrument cannot be included in the accompaniment.

#### **Adjudication**

- 15. No competitor, teacher, or parent may speak to the Adjudicator before the start of any session. The top three competitors in each class will be publicly adjudicated. All other marks will be announced with general comments only. Adjudication Sheets and Certificates may be obtained gratis, but must be collected from the Secretaries after adjudication. They will not be posted to competitors after the Festival.
- 16. Certificates will be awarded in all classes. Trophies will be awarded to winners with a mark of 85 or more in classes where trophies are shown.
- 17. In the event of a competitor being unable to compete at the time of the class as shown in the programme, the Adjudicator may, if an alternative opportunity arises, comment on the performance, but will not award any marks.

#### Administration

- 18. Entries may be made online at: wadebridgefestivalofmusicandspeech.com, by email or post and must be received by the Entry Secretary no later than Friday, 31st January, 2025. Entries will not be accepted unless the entrance fee is paid by Friday, 31st January, 2025. No refund for withdrawal will be made after this date. Entry fees may be paid by direct transfer/payment to the Festival's account at Barclays Bank plc Sort Code 20 74 20 Account number 40922455 quoting the entrant's surname as the reference. Alternatively, cheques should be made payable to Wadebridge Music Festival and sent to the Entry Secretary see page 4.
- 19. Entry Fees are shown on page 4.
- 20. The Committee reserves the right to cancel or combine classes as necessary.
- 21. Should a class be timed for a period during which the competitor is likely to be at school, the parents are asked to seek the co-operation of the head teacher.
- 22.The Committee requires the return of all Festival Trophies awarded in the 2024 Festival, (unless previously returned) by Monday, January 20<sup>th</sup> 2025. Engraving is optional and at the competitor's own expense. Please return all trophies to Mrs Jill Nute of Homebound, Gonvena Hill, Wadebridge PL27 6DH Tel: 01208 895559
- 23. Times shown in the programme will be approximate. Competitors should be in the hall at least 30 minutes before the commencement of the class. Competitors not present when their names are called may forfeit their right to compete.
- 24. The Committee would appreciate early notification if any member of a team or group is replaced because of sickness.
- 25. All classes are now open to all genders with the exception of classes 54, 55, 57, 58, 60, 61, 62 and 63.
- 26. Competitors are requested to provide their own music stands.

## **Copyright And Performing Rights**

- 1. Competitors are advised to secure their music as soon as possible. Due to the Copyright Act, no unauthorised photo-copies are permissible, with the following exception: when an Own Choice work is selected from a publication containing several different works, and is not published separately, one copy may be made for the use of the Adjudicator, provided that the competitor has already purchased his/ her own copy. The copy must be retained and destroyed by the administrator of the Festival immediately after the event. Should an extended photocopy be used by the performer to avoid page turning, the original score should be available if the Adjudicator wishes to see it.
- 2. The Festival has entered into an agreement with the Authors' Licensing and Collecting Society. This means that entrants do not have to seek copyright permission for any poetry or prose performed. Authors will be directly reimbursed as a consequence of their works being performed at this Festival.
- 3. To comply with Performing Rights competitors are asked to announce the title of their piece and the name of the composer/author.
- 4. No one may take photographs or make video recordings during performances.

# BIFF Child Protection Policy (adopted by Wadebridge Festival of Music and Speech)

The British and International Federation of Festivals for Music, Dance and Speech work for amateur festivals everywhere to help create thousands of educational performance opportunities for children and young people each year.

The Federation, and our member Festivals, are committed to ensuring safe environments for children and young people and believe that it is always unacceptable for a child or young person to experience abuse of any kind. We recognise our responsibility to safeguard the welfare of all children and young people, by a commitment to recommend best practice which protects them.

This policy applies to our Board of Trustees, paid staff, Adjudicator members, volunteers, students or anyone working on behalf of the Federation and our member Festivals.

#### We recognise that:

- the welfare of the child/young person is paramount
- all children, regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have the right to equal protection from all types of harm or abuse
- working in partnership with children, young people, their parents, carers and other agencies is essential in promoting young people's welfare.

#### The purpose of the policy:

- to provide protection for the children and young people who participate in our festivals, including the children of festival members
- to provide staff and volunteers with guidance on procedures they should adopt in the event that they suspect a child or young person may be experiencing, or be at risk of, harm

We will seek to safeguard children and young people by:

- valuing them, listening to and respecting them
- adopting child protection guidelines through procedures and safe working practice for staff and

volunteers

- recruiting staff and volunteers safely, ensuring all necessary checks are made
- sharing information about child protection and safe working practice with children, parents, staff and volunteers
- sharing information about concerns with agencies who need to know, and involving parents and children appropriately
- providing effective management for staff and volunteers through supervision, support and training.

The Federation will review this policy each year in November in line with Safe Network guidance or sooner in light of any changes in legislation or guidance. All changes will be communicated to our member Festivals in time for the start of the new Festival year.

#### **Creating Safer Festivals for Everyone**

The Federation and its member Festivals use the following policies and procedures to create Safer Festivals for everyone:

- 1. A single, definitive Child Protection Policy adopted by all Federation Festivals.
- 2. One or more designated Festival Safeguarding Officers (FSO) appointed for each Federation Festival. Name: *Ann Jones*
- 3. Best practice advice in the form of Safe Working Practice and Festival Child Protection leaflets, with support and training for all Festival staff and volunteers, including clear reporting procedures for anyone with a concern about a child.
- 4. Appropriate recruitment and induction procedures for all new Festival staff and volunteers responsible for providing safe environments for everyone attending / performing at a Federation Festival.
- 5. All Festival personnel wear an official badge. All teachers/parents/guardians / carers are asked to report all incidents of any nature to anyone wearing a badge. All reported incidents will be handled in accordance with the Safe Working Practice and Festival Child Protection best practice advice. In addition, we will ensure the availability of a quiet area / room where concerns can be expressed in private.
- 6. For the duration of a Festival all teachers/parents/guardians/carers are responsible for the continuous care and supervision of their own children/pupils. If they are unable to attend personally, they must delegate their responsibilities to an identified adult and ensure that their children/pupils are aware of the identity and name of the person responsible for their care. This includes supervision throughout all Festival venues, practice and changing areas that may be provided. The Festival cannot take responsibility for any property left unattended. Please note all accompanying adults will be required to pay an admission fee.
- 7. No photography, audio or video recording of children and young people is allowed during performances.
- 8. Some children and vulnerable adults may have specific needs in order to take part. If this is the case we ask the responsible teachers/parents/guardians/carers to contact the Festival Secretary prior to arrival. The Festival actively seeks, wherever possible, to meet these needs, but must know beforehand in order to prepare support, or to advise that help cannot be provided on this occasion.

9. The Festival's Child Protection Policy and approach to Creating Safer Festivals for Everyone is published explicitly in our Syllabus and Programme. By completing and signing the entry form all parents / guardians / carers and teachers of entrants under18 (or vulnerable adults of any age) confirm that they give (or have obtained) the necessary consents for the entrants to take part in the Festival. Without consent the entry to the Festival cannot be accepted.

#### **Privacy Notice**

**The Wadebridge Festival of Music and Speech** is a performing arts organisation run entirely by volunteers. New regulations about data protection came into force on 25th May 2018. Information such as names, addresses, dates of birth, email addresses and phone numbers can all be described as 'personal data'.

#### What information do we collect about you?

In our festival organisation we handle personal data regularly through paper entry forms, mailing lists, committee, accompanist and volunteer details, information about sponsors and Friends of the Festival etc. We will only ask for such information as is necessary for the efficient administration of the Festival. We do not ask for 'sensitive personal data' unless there is a legitimate reason for this – for example, where an entrant may need support to participate in a class, or where there is a legal requirement.

#### How will we use the information about you?

We collect information about you in order to process entry to classes in the Festival and for any other administrative functions of the Festival. Access to this data will be restricted to those personnel who administer the festival. It will be stored on password controlled computers; when hard copies are sometimes used to ease administration, they will be kept in a secure place.

#### **Legal Basis**

Personal data will not be collected and processed without your unconditional consent or where there is a legitimate interest.

#### Access to your data and correction

Everyone has a right to know what personal data we hold about them and, if they request it, to receive a hard copy of this information at any time. This information can be requested from the General Secretary (*morwennavernon@gmail.com*). We want to make sure that the personal data we hold about you is accurate and up to date and all reasonable efforts will be made to ensure this is the case. You may ask us to correct or remove any information you think is inaccurate.

#### **Retention of data**

Data may be retained according to the Festival's Data Protection Policy, which may be found on our website or by application to the General Secretary (as above).

#### Do we share this information with anyone else?

The festival will not pass collected data to any third party unless required to do so by law, but it should be noted that names (only) of competitors will appear in our Festival programmes and the names of class winners may be posted on the website and in the local press. If you do not wish a name to appear in any of these places, this should be made clear at the time of entry.

# ADJUDICATOR: Jenny Thornton Rules

- 1 Poems are to be recited from memory. Any actions will not impact on the adjudication.
- 2 Performances should not exceed 5 minutes unless stated.
- Entries in the composition classes must be the competitor's own original work and be performed at the Festival. A copy for the Adjudicator, with the entry fee, must be sent to the Entry Secretary by Friday, 31<sup>st</sup> January 2025.
- 4 All poems and set pieces are available on the website. Only these versions are acceptable.

#### Classes

Class 1 **VERSE SPEAKING PRIMARY SCHOOL YEAR 1** Entry Fee - £3.50 Set Piece: *The Future* by Sean Taylor (*The Dream Train by Sean Taylor*) or *Soggy Greens* by John Cunliffe (*Puffin Book of Fantastic First Poems*)
